- The Sponsor may not directly or indirectly state or imply that he/she/it is endorsed by the SBA nor may the Sponsor use the SBA logo on its own materials.
- No political sponsorships are permitted.

Marketing E-mail Program

Our members greatly value the resources offered by service providers in the legal community and they are continually seeking out new and beneficial partners. With the goal of presenting these valued businesses to our membership, the association sends one sponsor prepared e-mail each month that features a message about a single sponsor to our full e-mail list. This message, coming from the Scottsdale Bar Association Officers, describes the sponsor's product or service and includes a unique offer that is exclusive to our membership.

Our email list is not provided to sponsors as we must protect the privacy of our membership, however, the sponsor representative's contact information is clearly communicated and our members are strongly encouraged to directly contact that person for more information or to schedule a meeting.

As this opportunity is greatly desired by our sponsors, each sponsor e-mail may only be purchased as an add-on to a luncheon, social or the golf tournament 'name' sponsorship, and any given sponsor may only purchase no more than two (2) emails in a 12-month period. The e-mail need not be sent in the same month as any other scheduled sponsorship, however (e.g., the selected luncheon sponsorship or social sponsorship). The sponsor is required to provide the wording of their E-mail offer and any digital images to be used with the order submission.

Sponsor's net cost for this e-mail to members is \$500; combined price with one (1) luncheon sponsorship is \$900.

Sponsor's net cost for this e-mail to members is \$500 and is included in a combined price with the designated social sponsorship as noted above (\$1500 or \$1300).

Sponsor's net cost for a second e-mail, if desired, is an additional \$350.
